

# YOU AND YOUR RIGHTS

## Isibonelelo Sokukhulisa Ingane Ongayizali

Zonke izingane ezingaphansi kweminyaka engu-18 futhi ezidinga ukunakekelwa ngumzali zingangena kwinqubo yokukhuliswa ngumuntu onjengomzali, noma ngabe zivela kuliphi ilizwe.

Isibonelelo Sokukhulisa Ingane yimali yanyanga zonke ekhokhelwa labo bazali abangabakhulisi bezingane. Akusho lutho ukuthi wena uhola kangakanani.

Ngomhla ka-1 Ephreli 2018 inani lesibonelelo belingu-**R960** ngenyanga, ingane ngayinye.

Isibonelelo siqhubeka sonke isikhathi kuphela nje uma inkantolo ithe usengaqhubeka nokuba ngumzali okhulisa ingane. Kufuneka ukhokhelwe kusukela ngosuku lwalowo myalelo wenkantolo – yize noma ngabe wena isicelo sesibonelelo usifake ngesinye isikhathi, seludlulile lolo suku.

Ukuze ube ngumzali okhulisa ingane, kumele uthintane noMnyango Wezokuthuthukiswa Komphakathi ngakini noma nenhlangano efana ne-Child Welfare.

UNGAYIKHULISA njengomzali ingane eyilungu lomndeni.

Kumele ube yisakhamuzi saseNingizimu Afrika, ube ngumhlali kanomphela noma yisifiki esingumbaleki oneminyaka engaphezu kuka-18 futhi ube uhlala eNingizimu Afrika ukuze ube ngumzali okhulisa ingane.

Uma uneminaka engu-16 kuya ku-18 futhi ube wamukelwa njengomuntu oyinhloko yomuzi nguMnyango wesifundazwe Wezokuthuthukiswa Komphakathi, ungasithola isibonelelo Sokukhulisa Umntwana ngokusizwa umuntu ongaphansi kwesandla sakhe.

Njengomzali okhulisa umntwana angamzali, ungasifaka isicelo sesibonelelo ehhovisi lakwa-SASSA eliseduze nawe – akukho mali okudingeka uyikhokhe lapho ufaka isicelo.

Ubophatha izinhlobo ezihlukene zamadokumente lapho uya kwa-SASSA, njengoMazisi wakho namadokumente engane kanye nobufakazi besimo sakho somshado. Kepha uma ungenawo, UNGASIFAKA futhi isicelo ngokusebenzisa ezinye izindlela zokuzazisa.

Kuzodingeka uveze ubufakazi bokuthi nguwenona ngumzali okhulisa leyo ingane.

Uma isicelo sakho sivunyiwe, ungasifaka isicelo sosizo lwesikhashana ngokusebenzisa uSizo Lwezenhlalo Kwabantulayo ngenkathi usalindele ukufika kwemali yakho yokuqala. Imali yosizo lwezenhlalo kwabantulayo isiyodonswa emalini yesibonelelo sakho.

Uma umndeni wakho untula, ungasifaka isicelo "sesimo sokuba buhlwempu" eMahhovisi Kamasipala wangakini – futhi lokhu kungakusiza ezindlekweni zamanzi, ugesi nemali yama-rate endlu.

Kungenzeka ube ngovumelekile ukuthola imali yesondlo evela kubazali begazi baleyo ingane noma komunye umzali waleyo ingane. Lokhu kumele uzame ukukuthola ngomyalelo wenkantolo.
